

Iranian karate athletes snatched two gold medals at the 2023 AKF Senior Championships currently taking place in Malaysia.

On the opening day of the competition, Behnam Dehqanzadeh clinched the first gold for Iran's team in the Senior Kumite Male -55kg category. His victory came after a hard-fought battle, defeating Jordan's Omar Shaqrah with a score of 6-4 in the final.

Prior to cruising to the final. Dehqanzadeh showcased his prowess by defeating opponents from Turkmenistan, Sri Lanka, and Malaysia in earlier rounds.

Adding to Iran's success, Atousa Golshadnezhad also stood tall as she secured a gold medal in the Senior Kumite Female -61kg division. She outclassed her Emirati opponent Sarah Alameri with a convincing 3-0 victory, earning the title of Asia's champion in her category. Iran's karate contingent continued to shine, with Amir Mehdizadeh earning a bronze medal in the Senior Kumite Male -67kg category. Meanwhile, Fatemeh Sadegi in the Kata Female and Abolfazl Shahrjerdi in the Kata Male secured their places on the podium, finishing third in their respective events.

Iran raps US for blocking its bid to host maritime event

Iran's Foreign Ministry spokesman Nasser Kanaani strongly condemned the US move to prevent Iran from hosting an international maritime event in October, saying that Washington once again revealed its arrogant and colonial nature. Iran had proposed to host a shipping event in Tehran in late October this year, in conjunction with an annual maritime day hosted by the UN's International Maritime Organization (IMO), which was accepted in 2015 by the IMO's Executive Council. However, Iran's offer to host the event was rejected after a proposal led by the US to rescind the bid was approved in a vote at the UN shipping agency's council on Thursday.

Kanaani said that the US move showed that Washington recognizes no limits in politically abusing the United Nations' technical and specialized agencies. The Iranian official denounced the US for ignoring the majority vote of the IMO member states.

The US, in a working paper seen by Reuters and submitted to the IMO's Council, which is meeting this week, proposed rescinding the decision.

It alleged in the paper, which was co-sponsored by Britain, that "Iran has seized, or attempted to seize, commercial vessels with no pretext, warning or prior justification."

Fierce dust storm hits SE Iran



IFP - A dust storm packing winds of up to 126 kilometers per hour hit the city of Zabol, in Iran's southeastern province of Sistan and Baluchestan, in the early hours of Friday.

The storm decreased visibility to 400 meters horizontally, according to the director of meteorology for Sistan and Baluchestan Province.

An emergency official for the province said around 1,000 people had sought medical help because of the dust storm within the last three days. Dozens more had to be hospitalized.

Muslims strongly condemn new desecration of Qur'an in Sweden

Muslim-majority nations and governments expressed outrage over the second incident of a state-authorized desecration of their holy book in Stockholm, Sweden, in less than a month.

Salwan Momika, a Sweden-based Iraqi refugee who burned a copy of the Qur'an in Stockholm on June 28 under the protection of the Swedish police, stomped and kicked another copy of the Qur'an, but left the protest outside Stockholm's main mosque without burning the holy

Following the announcement, millions of Muslims took to the streets of Iran and other Muslim-majority countries to voice their strong condemnation of the desecration.

In a communiqué issued after the rallies on Friday, the demonstrators called on the Iranian Foreign Ministry to reconsider diplomatic relations with the Swedish government in tandem with other Muslim countries.

izens, who were angered the most, even stormed the Swedish Embassy in Baghdad early Thursday, overran the diplomatic compound, and started a small fire. The embassy staff had been evacuated a day earlier in anticipation of the strong response.

Hours later, Iraq's prime minister cut diplomatic ties with Sweden in protest over the desecration of the Islamic holy book, Press TV reported.

Following repeated desecration of the Holy Qur'an in Sweden, Iran's Foreign Min-

ister Hossein Amir-Abdollahian wrote to Antonio Guterres on Thursday, urging the UN secretary-general to take a hard line on such acts of religious sacrilege.

Amir-Abdollahian reminded the UN chief that Momika's previous act of sacrilege had caused "serious harm"

to the sentiments of Muslims and other followers of divine religions across the world. "The shock and concern about such insulting actions are on the rise," the foreign minister added.

Iran strongly denounces the Swedish authorities' issuance of their approval

for the provocative act, the letter went on.

In a telephone conversation on Thursday, Amir-Abdollahian and his Iraqi counterpart Fuad Hussein strongly condemned the desecration of the Holy Qur'an in Sweden, calling for an urgent meeting of the Organization of Islamic Cooperation (OIC) to discuss the matter.

The two diplomats described the defiling of the Qur'an as an insult to rationality and freedom of speech and condemned the irresponsible behavior of the Swedish government.



Escalation of tensions in no one's interest

Following Robert Malley's removal from his position as the US special representative for Iran affairs, recent news regarding the stances of Washington and Tehran indicates a shift away from earlier optimism and a non-productive trajectory between the two sides. Despite political analysts foreseeing a positive turn in negotiations between Iran and the United States following the king of Oman's visit to Iran in late May, current developments suggest that both nations are heading toward increased tensions. The dismissal of Malley, who was known for his successful talks with Iranian parties in Oman. Oatar. and New York, has altered the course of events in both countries. Instead of constructive engagement, the United States continues to assert unfounded claims against Iran. Recently, they announced plans to deploy more ships and soldiers to the Persian Gulf, citing Iran's alleged destabilizing activities as a pretext. Last week, a senior official from the US Defense Department stated that they will increase the use of F-16 fighter jets in the region to protect ships from Iran's actions.

Moreover, the United States, with Britain's support, exerted pressure on the United Nations to revoke Tehran's hosting of the World Maritime Day. This further exacerbates the strained relations between the nations. In addition to these developments, the US federal prosecutor has issued an order to auction 800,000 barrels of Iranian oil, which was allegedly seized by American forces. Responding to this move, Alireza Tangsiri, the commander of the IRGC Navy, issued a stern warning. He declared that any American oil company attempting to remove the oil from the tanker would be held accountable, and he also held the US responsible for these actions. With these recent events, the prospects for productive dialogue between Iran and the United States appear dim, and both sides seem to be heading toward an escalation of hostilities.

Iran's Defense Minister Mohammadreza Ashtiani responded to the deployment of American warships and fighters to the Persian Gulf, asserting that the Islamic Republic is currently at a stage of authority and capability where it cannot be threatened by anyone. He emphasized that Iran plays a significant regional and international role.

While Iran has been managing regional tensions in West Asia with an interactive approach and striving for de-escalation, the recent threatening positions and behavior of the United States toward Iran are concerning. The reasons behind America's hardening stance may stem from Israel's isolation in the region, internal rivalries within the United States, or the ambiguous situation of the war in Ukraine. Regardless of the origins, the path taken by the United States and Europe toward Iran does not appear to serve the inter-Expectations were that the United States would

In the event that the United States persists in its tension-inducing positions toward Iran, Tehran is prepared to utilize its capabilities to respond. The continuation of the current situation could further complicate Tehran-Washington political dialogue regarding the revival of the 2015 nuclear deal and the lifting of sanctions. Ulyanov: Prospects of JCPOA revival currently dim

The prospects for restoring the Joint Comprehensive Plan of Action (JCPOA), commonly known as the Iran nuclear deal, are currently extremely dim, said Russia's permanent envoy to the international organizations in Vienna.

Mikhail Ulyanov made the remarks in an interview with the Russian newspaper Izvestia, published on Friday, according to Mehr news agency.

He reminded everyone that negotiations on the restoration of the Iranian nuclear deal were held in Vienna from April 2021 to March 2022.

"A detailed decision was then prepared, which provided for the phased lifting of all US sanctions against Iran and the simultaneous return of Tehran to those parameters of its nuclear program that were included in the JCPOA," he said.

However, he added, "the favorable and appropriate moment" was lost, and absolutely nothing has happened in the last vear and a half.

The Russian diplomat noted that the problem lies mainly in the position of Berlin, London, and Paris, as well as Washington, which unilaterally withdrew from the deal back in 2018.

"In my opinion, they are making a strategic mistake, because the issue is in limbo, and tensions can escalate at any moment, bearing extremely unpleasant consequences," Ulvanov warned.

N Korea threatens nuclear retaliation over US displays of military force



North Korea said on Thursday deployment of US aircraft carriers, bombers or missile submarines in South Korea could meet criteria for its use of nuclear weapons, state media KCNA reported, citing the country's Defence Minister Kang Sun Nam. The comments raise the stakes as each side steps up displays of military force in a standoff over

the isolated country's nu-

clear weapons and ballistic missile programs, Reuters reported.

The defence minister's statement also accused the United States and South Korea of escalating tensions in the region while criticizing the first meeting by their Nuclear Consultative Group (NCG). "The ever-increasing visibility of the deployment of the strategic nuclear submarine and other strategic

assets may fall under the conditions of the use of nuclear weapons specified in the DPRK law," the statement said.

DPRK is short for the North's official name, the Democratic People's Republic of Korea.

Kang's remark was aimed at the nuclear-armed Ohio-class US ballistic missile submarine that arrived at a port in the southern city of Busan earlier this week.

"The phase of a military clash on the Korean Peninsula has surfaced as a dangerous reality," the KCNA report said.

South Korea's Ministry of National Defense said on Friday the NCG meeting and the deployment of the USS Kentucky were "just defensive countermeasures" against the North's nuclear and missile threats. The KCNA report came after a US soldier crossed the border into North Korea on Tuesday at a time of heightened tension between the two Koreas and the United States.

North Korea has yet to comment on the incident involving the US soldier. Last year, the state codified a new, expansive nuclear law declaring its status as a nuclear-armed state "irreversible".

Zelenskiy sacks Ukraine's ambassador to UK after criticism



President Volodymyr Zelenskiy dismissed Vadym Prystaiko as Ukraine's ambassador to Britain on Friday, days after the envoy publicly criticised the president. A presidential order, which said Prystaiko had also been removed as Ukraine's representative to the International Maritime Organization, gave no reason for the dismissal, Reuters reported. In an interview with Sky News

last week, Prystaiko was asked about remarks by outgoing British Defence Secretary Ben Wal-

lace suggesting Kyiv should show more gratitude for weapons deliveries from its allies to fight Russian forces.

Zelenskiy responded by saying Ukraine was always grateful to Britain, a staunch ally. He was also quoted by British media as saying Wallace could let him know how to express his gratitude or how "we could get up in the morning and express our words of gratitude to the minister."

Asked whether Zelenskiy was being sarcastic, Prystaiko told Sky there was "a little bit of sarcasm" when the president "said that each and every morning he will wake up and call Ben Wallace to thank him."

"I don't believe that this sarcasm is healthy," he said, adding that the Russians "have to know that we're working together."

Zelenskiy's order did not say who would replace Prystaiko, 53, an experienced diplomat and former vice prime minister who had held the post as ambassador to Britain for three years.

White House regrets Kissinger had better access in Beijing than US officials

The White House on Thursday expressed regret that Henry Kissinger was able to get more of an audience in Beijing than some sitting US officials, after the former top diplomat held talks in China.

kissinger – an architect of normalizing ties between Washington and Beijing in the 1970s as secretary of state and national security advisor in the administrations of Presidents Richard Nixon and Gerald Ford – was welcomed warmly as an "old friend" by Chinese President Xi Jinping on Thursday amid efforts by Beijing and Washington to mend frayed ties, Reuters repported.

The White House said it was aware of the trip but that it was a private visit by a citizen.

As part of those meetings, Kissinger, 100, also met with China's top

diplomat Wang Yi and with defense minister Li Shangfu, who has declined direct talks with US Defense Secretary Lloyd Austin. General Li, appointed in March, remains sanctioned by the US over his role in a 2017 weapons purchase from Russia's largest arms exporter, Rosoboronexport. Chinese officials have repeatedly said they want those sanctions, imposed in 2018, dropped to facilitate discussions.


"It's unfortunate that a private citizen can meet with the defense minister and have a communication and the United States can't," said White House National Security Council spokesperson John Kirby.

"That is something that we want to solve. This is why we continue to try to get the military lines of communication back open because when they're not open and you have a time like this when tensions are high, miscalculations also, then the risk goes high."

Kirby said that administration officials "look forward to hearing from Secretary Kissinger when he returns, to hear what he heard, what he learned, what he saw."

Tensions between the world's two largest economies have heightened over a range of issues, including the war in Ukraine, Taiwan and trade curbs.

Washington has tried to reestablish communication channels on these and other issues through recent high-profile diplomatic visits.

British PM avoids wipeout in local polls



Shahrud, a heaven for nature lovers

Iran is a four-season country. however since the country's lack of water is often discussed, the general perception is that Iranians live in the middle of a desert and are constantly facing drought and its subsequent problems.

But in every corner of Iran you can find an amazing landscape and a pristine nature.

The city of Shahrud, in Semnan Province, is the only place in Iran from various directions of which you can reach a mountain, a forest and a desert in 30 minutes, and a sea in less than three hours, IRNA wrote.

Shahrud, which is the second largest city of Semnan Proving Tehran to the holy city of Mashhad.

From the north, it is surrounded by the Alborz Mountains, and from the south, by the arid salty deserts. The river of Tash, after crossing this town, reaches the south deserts.

The weather on its mountainous areas is cold, while it is somewhat temperate in other parts of the city.

If you travel south for 30 minutes from Shahrud, you will reach a vast desert called Torud, having beautiful palm groves, the residents of which make a living from camel breeding.

And if you travel north for 30 minutes, you will encounter a the northern provinces of Gilan and Mazandaran.

There is a cold and snowy region at a distance of one hour from the east side of the city, the climate of which is similar to that of Kurdestan and Lorestan provinces

In the city of Mojen and the Tash-e Olya village, located at a short distance from western Shahrud, you will encounter people wearing jackets and warm clothes in late July and early August. They have to turn on heating devices at

Cloud Forest (Abr Forest) is among the well-known natural attractions and one of the most extraordinary sights of the sky seems to have approached the earth.

The forest is one of the oldest in the world, dating back forty million years, belonging to the Jurassic period. It is a continuation of the lush forests of the north, and has an area of 35,000 hectares. One of the main features of this forest is its high altitude; as it has low temperatures in hot seasons.

The average maximum temperature in this forest is 20°C, while the nights and early mornings are very cold.

Shahrud, with numerous green and old plane trees, has several beautiful parks which are among its well-known attractions.

The oldest plane tree of the

city, called chenar-e sookhteh, (chenar means plane tree) is located in the middle of a square with the same name. The tree has been registered on Iran's National Heritage

A variety of animal and plant species live in the forest which is covered with clouds for most days of the year.

All the valleys leading to the villages are full of fruit or-


If you go there in the summer, various types of seasonal fruits such as apricots, peaches and cherries will delight your eyes.

Khaar Turan National Park,

located in the region, consists of three major parts: a protected area, a national park, and a wildlife refuge. It is the second-largest protected area in Iran, having rare animal and plant species.

The biosphere reserve of Khaar Turan National Park, known as the Africa of Iran, is the largest in Iran.

No matter where you are in the country, you have access to at least one direct road to Shahrud. Moreover, the Shahrud railway is one of the busiest in the country.

Chogha Mish in lowland Susiana lar, but on its northeast, east and (in modern-day Khuzestan Province), is the largest pre-Sassanid settlement in northeastern Susiana, and is strategically located between the outlets of the large perennial rivers of Dez and Karun in the plain.

Closer to the site are two important tributaries of the Dez River, the Siah Mansur, some 10km to the west, just west of Jundi Shapur, and the Shur, slightly less than 1km to the east Mish.

The mound of Chogha Mish consists of a truncated cone-shaped high mound to the north overlooking a large terrace to the south. The summit of the high mound is at elevation 100.54m above sea level. It is about 27m above the surrounding plain and over 30m above the riverbed of the Shur, to the east. Its western edge is fairly regusoutheast sides it has four irregularly shaped lobes separated by deeply eroded gullies.

Eleven seasons of excavations at the site provided a long, uninterrupted prehistoric sequence of cultural development in southwest Asia.

Chogha Mish is therefore uniquely qualified to demonstrate at a single locus a series of major developments that took place during the entire Neolithic period in southwestern Asia.

These developments include the gradual appearance of central places, increasing specialisation and improvement in the production of material culture, changes in subsistence economy, and the emergence of chiefdom and proto-state societies.

The earliest cultural phase discovered at Chogha Mish, the Archaic Susiana, dates to 6,800 BCE.

Cultural phases much earlier than the basal levels of Chogha Mish were accidentally discovered in the nearby mound of Chogha Bonut. The continuation of the Archaic period thus will have to be sought at Chogha Mish.

The initial occupation of Chogha Mish is marked by the presence of the earlier painted-burnished variant and its developed version, the standard painted-burnished ware. Sometime during the Archaic Susiana phase 1, the paint $ed \ burnished \ \bar{variant} \ completely$ disappeared.

The standard painted burnished


Ware was associated with other artefacts, for example, the tiny T-shaped figurines, which occur both in Susiana and Dehluran to the north.

Striking parallels can be found in the pottery and figurines from the distant sites in the Iranian central plateau. The T-shaped figurines are frequently interpreted as belonging to a Zagros complex but they have a wider distribution since we have closely similar material far to the northeast of Iran.

Architectural remains of this phase at Chogha Mish were inconclusive.

They consist of poorly preserved pisé and mud brick wall fragments, beaten earth surfaces and several cooking installations. The use of long bricks continued into this phase. As in the earlier and later phases, the floors of the cooking installations were covered with fire-cracked rocks. No change in the subsistence economy was noted from the previous

A total of eight medals - including three golds – across 10 weight classes saw Iran clinch the freestyle crown at the Asian U20 Wrestling Championships in Amman.

Despite being the second best against the Indians in four head-to-head final showdowns, Iranian boys still finished atop the standing with 191 points, adding the freestyle triumph to the Greco-Roman crown in the Jordanian capital.

India settled for the runner-up spot with 180 points, with Kazakhstan in third place on 160

On Thursday, Amir-Ali Pouladi rounded off a glittering campaign for Iran with the superheavyweight gold thanks to a 7-2 victory over Mongolian Nambardagva Batbayar in the 125kg final.

Iran's first gold of the afternoon came in the 92kg weight class, where Mohammad-Mobin Azimi defeated Sherzod Poyonov of Uzbekistan 8-2 in the final.

The two golds came after Ali-Abbas Rezaei had outmuscled Japanese Taishin Yamaji 8-0 to walk away with the ultimate prize of the 70kg contests on the preceding night.

However, Indian opponents proved to be intimidating for the Iranian boys, who managed only one victory in six bouts against the wrestlers from the new Asian wrestling force - a last-four win by technical su-

periority for Pouladi over Rajat

Ruhal.

Ebrahim Khari left Amman with the 57kg silver after a 7-4 loss to Udit Udit, while a second final showpiece featuring Iranian and Iranian wrestlers saw Ebrahim Elahi suffer a 9-1 defeat against Singh Jaskaran. Sagar Jaglan added another gold to India's medal haul with a 6-3 win against Iranian Farzad Safi Jahan-Shahi in the 79kg final.

Amirhossein Alizadeh also left the mat empty-handed against Mukul Dahiya in the 86kg final – falling to a 3-0 defeat – as India topped the medal table with a remarkable five gold medals, as well as three bronzes - followed by Iran and Kazakhstan, which finished with double golds and six bronzes.

Meanwhile, Iranian Hossein Mohammad-Agaei took the fifth silver medal for the country, when he was beaten 10-0 by Kazakhstan's Yerkhan Bexultanov in the 74kg final.

Iran's hard-fought freestyle title followed an emphatic run at the Greco-Roman event in Amman, where all Iranian wrestlers finished their campaigns with a medal to help the country cruise to the title with 205 points - 25 points clear of second-place Uzbekistan.

Mohammad-Morad (60kg), Ahoura Bouveiri (67kg), Abolfazl Choubani (87kg), Amir-Reza Akbari (97kg), and Fardin Hedayati (130kg) bagged five gold medals in their respective weight classes.

Mohammad-Mehdi Miri took the 72kg silver, with Ali Ahmadi Vafa (55kg), Reza Qeytasi (63kg), Alireza Abdevali (77kg), and Yasin Yazdi (82kg) leaving the event with four consolation

Later on Thursday, a 16-point performance by Polish outside-hitter Aleksander Sliwka led the home side to a 3-0 (26-24, 25-21, 25-20) win against volleyball giant Brazil.

Wilfredo Leon Venero (11 points) and Mateusz Bieniek (10) also finished in double figures for Poland, while Alan Souza and Ricardo Lucarelli topped the scoring for the Brazilians with 15 and 10

points respectively.

The other last-four clash today will see reigning world champion Italy go head-to-head with USA – last year's VNL runner-up. USA defeated France in a five-set thriller (25-21, 25-18, 17-25, 24-26, 15-9) on Wednesday to avenge the defeat against the Tokyo Olympic gold medalist in last year's final.

Matthew Anderson scored 22 points for the Americans, with Thomas Jaeschke and Torey Defalco respectively finishing on 16 and 12 points.

In the absence of injured outside-hitter Earvin N'Gapeth, Jean Patry led the scoring chart for France with 17 points – followed by Barthélémy Chinenyeze (16 points) and Nicolas Le Goff (14).

Elsewhere on Wednesday, Italy made a quick work of Argentina in three sets (25-17, 25-13, 25-14) to advance into a second successive semifinal - thanks to a 15-point display by Alessandro Michieletto

Daniele Lavia and Yuri Romanò had 12 and 11 points for the world champion, while Agustin Loser tallied 10 points for the South Americans, whose first-ever appearance in the VNL Finals came to an early finish.

Iran stood 22nd – second to Japan in Asia – in the latest FIFA Ranking - released on Thursday - with 1556.59 points





Iran-EU five-month trade nears €1.9b: *Eurostat figures*

Trade between Iran and the European Union (EU) member states reached €1.869 billion in the first five months of 2023, according to data released by the European Union's statistics office Eurostat.

Based on the Eurostat data, trade between the two sides fell 10 percent in the said five months, in comparison with the same period last year, when the figure stood at €2.073 billion, reported Mehr news agency.

The EU's exports to Iran from January to May 2023 stood at €1.517 billion, registering a decrease of six percent compared to the same period last year, when EU exports to Iran were

The European Union's imports from Iran also reached €352 million in the first five months of 2023, with a 24 percent decrease compared to the same period last year. EU imported €463 million of goods from Iran in January-May 2022.

Subsidence raises alarm for many parts in Iran: MP



Mohammad-Saleh Jokar, a member of Iran's Parliament, issued a stark warning about the escalating environmental crisis of subsidence, a phenomenon that is wreaking havoc across various regions of the nation.

Jokar elucidated that subsidence, the sinking or settling of the ground's surface, is a direct consequence of long-term droughts and the excessive depletion of the underground water sources. "This environmental anomaly," he cautioned, "could precipitate catastrophic damages and disasters in diverse settlements and regions, thereby necessitating urgent action to secure stable water sources and facilitate water transfer to drought-stricken areas"

Iran has been grappling with a significant decrease in rainfall, leading to a surge in the digging of deep wells to extract water from underground aquifers.

"Regrettably, the scanty

rainfall is insufficient to replenish the depleted water reserves, resulting in the exhaustion of underground aquifers," Jokar said, adding, "This



He conceded that the government is grappling with a dearth of financial resources for the swift implementation of these projects. However, he suggested that in the mineral-rich low-water regions, the mineral revenues could potentially be leveraged to fund these water transfer projects.

Russia to issue electronic visas for Iranians, others

The Press Service of the Ministry of Economic Development of the Russian Federation announced that tourists from certain countries, including the Islamic Republic of Iran, will be able to obtain electronic visas for Russia in less than a week.

According to Russian news sources, the ministry stated that, as per the government's directive, citizens of European countries, Iran, Japan, Turkey, China, North Korea, India, Indonesia, the Philippines, Bahrain, Kuwait, Malaysia, Saudi Arabia, and Singapore will be eligible to apply for electronic visas, IRNA reported.

As reported, the issuance time for Russian visas within this framework will be less than six days



from the date of application.

The ministry clarified that electronic visas can be obtained through the internet for tourists. guests, or business trips, as well as participation in scientific, cultural, sports, and other events. According to the announcement, these electronic visas will be issued by a diplomatic mission or consular

office of the Russian Federation, and foreign nationals will need to submit their applications through a special website of the Russian Ministry of Foreign Af-

Based on this information, electronic visas will allow tourists to enter Russia once and will be valid for a maximum stay of 60 days from the registration date.

Iran's ancient 'wind catchers' beat the heat naturally

Tall, chimney-like towers rise from centuries-old adobe houses in Iran's desert city of Yazd, drawing in a pleasant breeze for residents of one of the hottest cities on earth.

The wind catchers, called badgirs in Persian, are just one of the engineering marvels inhabitants have developed in this ancient city in central Iran where temperatures reach well over 40 degrees Celsius (104 Fahrenheit) in the summer, Barrons

And, unlike energy-guzzling air-conditioners, they're cost and carbon-free.

"For centuries, before we had electricity, they made it possible to cool dwellings," said Abdolmajid Shakeri, the provincial deputy of Iran's cultural heritage and tourism ministrv.

The oldest of the city's 700 wind catchers dates back to the 14th century, but the architectural feature is believed to date back as far as 2,500 years when the Persian Empire ruled over much of the Middle East.

"The *badgirs* played a key role in the city's prosperity," said Shakeri about the desert city that was a caravan stop on the ancient Silk Road.

'Thanks to them, people lived at ease," he added, describing how the wind catchers pull fresh air into buildings and allow hot air to ventilate out through large vertical slots.

Majid Oloumi, the head of Dowlatabad garden, home to a towering 33-metre (100 foot) wind catcher – one of the tallest in the world – described the

cooling method as "totally clean because it uses neither electricity nor polluting materials".

UNESCO listed Yazd as a World Heritage Site in 2017, describing the city as a "living testimony to intelligent use of limited available resources in the desert for survival".

The bioclimatic architecture which provides thermal comfort for the people of Yazd has attracted interest elsewhere on a heating

"Badgirs demonstrate that simplicity can be an essential attribute to sustainability." said Paris-based architect Roland Dehghan Kamaraji, who has studied Iran's wind catchers.

"It goes against the common misconception that sustainable solutions need to be complex or high-

At a sustainable urban community called Masdar city in the United Arab Emirates, buildings have been "designed to make use of the natural ventilation for cooling, like badgirs," he said.

Similarly, ventilation inspired by "termite mounds, an approach similar to that of badgirs" were built atop Eastgate Centre, a shopping mall and office complex in Harare, Zimbabwe.

However, Yazd's unique architectural traditions have largely been abandoned at their birthplace.

"Unfortunately, or tral heritage has been forgotten," especially since the emergence of air conditioners, said Oloumi.

Yazd's old town is a labyrinth of narrow streets and roofed alleyways. Its centuries-old edifices made of clay, mud-brick and adobe all provide insulation against the torrid

But the old houses stand in sharp contrast to modern cement buildings and multi-lane roads.

"Today, house architecture imitates that in other countries, and cement-based construction does not correspond to the climate of Yazd," he added.

Kamaraji says bioclimatic architecture has waned due to economic constraints and modern construction methods that "largely favor the use of energy and fossil fuel intensive materials".

Another sustainable archi-

tectural feature of Yazd is its system of underground aqueducts called ganats, which transport water from underground wells, aquifers or the mountains. "These underground aqueducts have great utility," said Zohreh Montazer, an expert on the water system. "They constitute a source of water supply and make it possible to cool the dwellings and to preserve food at an ideal

temperature." Iran is estimated to have around 33,000 operational ganats today, a significant drop from the 50,000 in use in the mid-20th cen-

UNESCO says the decline in ganats is driven in part by the drying up of underground water sources due to overconsumption.

Iranian authorities have in recent years sought to rehabilitate the ganat of Zarch - considered the longest and oldest, dating to some 3,000 years ago.

The water network which stretches over 70 kilometers across Yazd, and runs at a depth of around 30 meters - stands as a reminder for Yazd's residents of the challeng-

es ahead. "The day when fossil fuels run out," said Montazer, "we will have to return to these methods."
